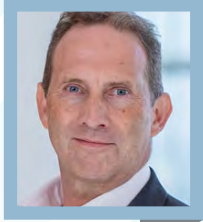

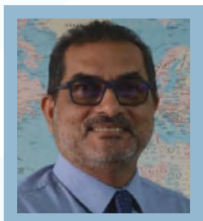
Christian Zenner
