Strategic Response

- COVID-19 The GT Senior Management Committee has been in-place since March 2020 centrally, to
 ensure all government guidelines are followed and to provide a cohesive group strategy / response on how
 to limit the impact on our staff and service delivery levels across all business units
- COVID-19 The Workplace Policy, COVID-19 Suspect Handling Process maps and associated RASSOW's were created, communicated and circulated to all GT employees and business units
- A dedicated Human Resources team remain in regular contact with all staff affected by COVID-19 both centrally and at local business unit level, to provide guidance and support in conjunction with local authority guidelines

Actions taken to minimize infections

- Virtual meetings are encouraged and embraced where possible
- Safe social distancing practices are ensured
- Additional safety signage has been created to communicate effective COVID-19 safety protocols
- All non-essential travel has been suspended until further notice
- Enforcement of physical social distancing in the workplace along with the supplying and wearing of gloves and masks when working in proximity of others
- Rearrangement of workspace into socially distanced patterns along with periodical cleaning and disinfection of all operational areas of the business including equipment
- Employees trained on how to prevent the spread of COVID-19 in the workplace and at home, combined with the use of regular communications via social media
