
### **ALESON SHIPPING LINES**

- Main port of call is Zamboanga City.
- Also covers Dapitan, Dumaguete, Jolo, Basilan and Tawi-Tawi.
- 1994: President Fidel V. Ramos spearheaded an economic and trade relations with the country's neighbors, which started the establishment of the BIMP-EAGA.
- ALESON MV Danica Joy 1 Pioneer vessel that sailed the route of Zamboanga City and Sandakan Port, Malaysia.
- Danica Joy 1 was upgraded to Danica Joy 2 to sail the route once a week. During her off-Sandakan route, also sails the Zamboanga-Jolo route.
- Always filled with traders, cargoes and deportees.
- Vessel upgraded into MV Antonia to cater to more passengers and provide better facilities for comfort.



#### ALESON SHIPPING LINES

- Zamboanga City Sandakan Route: Vessel caters to traders and visitors.
- Transport seasonal goods such as seaweeds, mangoes etc.
- ALESON is the only company legally compliant with government regulations.
- Government agencies such as the Bureau of Immigration, Philippine Ports Authority and the Philippine Military are involved to ensure safety, provision of proper documents and monitoring of cargoes.
- 1999: Company expanded into containerized cargoes. §
   Addition of new and bigger cargo vessels Con-Carriers.
- Serve the ports of Manila, Cebu, Bacolod, Kalibo, Dipolog, Dumaguete and Zamboanga.
- 2004: Acquired first fast craft MV Seajet.
- Presently, Aleson operates a fleet of 38 vessels and a major shipping operator in Western Mindanao.

- Started as a humanitarian cause by my grandfather with his strong commitment to pursue sea-connectivity in the region.
  Requested by the government to cater to the Zamboanga-Sandakan
- Requested by the government to cater to the route via BIMP-EAGA.
- Operated at a loss for several years but stuck with commitment for humanitarian reason and BIMP EAGA vision.
- Through the years, Aleson became a key contributor to economic activity.





# Challenges

#### Sailing Facts

- Have been sailing servicing the sector Zamboanga Sandakan for 25 years or since BIMPEAGA incepted
- No major security nor safety issues reported during the 25 years sailing period.
- Carried passengers and cargo across EAGA more than any other services and benefited traders in the process.
- MV Antonia1 is a replacement new vessel of increased passengers and cargo capacity after serving for 20 over years

# Challenges

- Since 2018, IMO imposed whilst renewing certificates and licences, as of September 2019 MV Antonia 1 was placed at drydock for servicing and regular maintenance.
- 30th November 2019, MV Antonia 1 called and approved to sail back to Sandakan but only to collect deportees. No common passanger nor cargo allowed.
- Since deportees mission started. There has no reported casualties.



### **RECOMMENDATIONS - IMO**

- The new vessel will be a newly constructed ship and will be ready by year 2025
- On the investment of Antonia-1, BEBC opines the authorities should consider their services of 25 years and its contribution to the EAGA region.
- Whence BEBC hopes for special case for this particular sector only that the Antonia-1 (cargo & passengers) allowed continue to sail until end of year 2025.
- Security & Sovereignty is not to be compromised whence we seek the wisdom of the TMM for a unilateral bilateral arrangement made to this effect.
